### **Collection**

- The registration note must be submitted when collecting the horse
- Costs incurred must be paid immediately per EC-Cash, credit card or in cash. The account total will be advised at the discharge talk or can be asked for.

### **Terms and Conditions for Admission and Treatment**

1. The deliverer / owner is informed that any operation or intensive treatment represents a significantly higher level of stress for the horse and therefore also an increased risk of general infection.
2. The risks of the operation and/or that of the required anaesthesia have been explained to the deliverer / owner. The undersigned declare their consent that the necessary diagnostic and therapeutic measures are to be carried out including anaesthesia.
3. The deliverer / owner has the duty to declare upon admission any of the horse's previous treatments, operations, diseases and allergies. We refer to the relevant passage above.
4. Animal Clinic Telgte GbR has the right to carry out any necessary treatments /operations needed on medical grounds or emergency euthanasia of the animal, also without the direct permission of the deliverer / owner, provided this is required to alleviate suffering or to save the animal.
5. No guarantee is given in any instance that an operation or treatment will be successful. The owner and/or the deliverer representing the owner has been informed of the type of treatment / operation to be carried out and the possible risks. Consent to treating and operating the horse has been given in full knowledge of the risks involved. Any claims for damages based on typical risks and/or complications are excluded.
6. The animal clinic's liability and that of the veterinary surgeons working at the clinic and/or its assistants is limited to a maximum of 1,000,000 € in all cases of simple negligence. Any typical loss, which can be envisaged at the conclusion of the contract, is covered by this sum. Tierklinik Telgte GbR does not accept liability for damage or loss of animals due to accidents, infectious diseases or acquired illnesses or injuries, which have not been caused by negligence in the clinic. The animal clinic's further liability and that of the veterinary surgeons working at the clinic and/or its assistants is unaffected in the case of intent and gross negligence, as well as losses incurred due to fatal injuries, physical injuries or health damages.
7. The animal clinic's liability and that of the veterinary surgeons working at the clinic is limited to one year in cases of simple negligence. This limitation period does not apply to losses incurred due to breach of duty, which has been caused by gross negligence or with intent by the animal clinic and the veterinary surgeons working at the clinic and/or its assistants, neither for losses incurred due to injuries to life, body or health.
8. The stabled horse will be released upon submission of the admission note at the agreed time. The Tierklinik Telgte GbR is not obliged to check the identification of the collector.

The daily rate may be doubled if the owner / deliverer does not collect within two days after having been notified by the animal clinic.

9. Tierklinik Telgte GbR has the right in exceptional circumstances to transport the horse to a stable nearby. The cost for the transport of horses is 0.60€ per travelled kilometre, a minimum, however, of 30.00 €
10. The owner / deliverer gives his consent that the horse may be treated in the case of a therapy emergency with medicines, which are not authorised for the use with horses or other food-producing animals. Therefore the owner / deliverer is aware that the above named horse cannot be used for the production of food and that the usage of the above named horse for food production breaches the regulations of the (Lebensmittel- und Bedarfsgegenstände- und Futtermittelgesetzbuch LFGB) – the Code Covering Food, Articles of Daily Use and Feed and can be prosecuted as a criminal offence. The owner / deliverer must ensure without delay that the appropriate entry is made into the horse's passport.
11. Tierklinik Telgte GbR has the right to retention when the remuneration account has not been paid in full, also that accrued from the treatment of other horses belonging to the same owner or deliverer.
12. Patient records prepared in the animal clinic, particularly case sheets, examination reports, x-rays and other notes are clinic property. The owner / deliverer has no right to the return of original documents. The owner's / his authorised representative's right to see the records and/or to receive copies at his own expense and the duty of the treating clinic doctor to give a report within the legislative framework remains unaffected.
13. No liability is accepted for any type of vehicle parked on the clinics site nor is any liability accepted for the loss or damage of any horse equipment, which has been handed over at the admission (halters, lead reins, covers etc.)
14. Arrangements, which differ from the admission note, must be made in writing to become valid.
15. German Law is exclusively applicable to this contract. Place of Jurisdiction is Amtsgericht (Local Court) Warendorf or the Landgericht (Regional Court) Münster.
16. Should individual conditions of this contract become invalid or impractical or become so after conclusion of the contract, then the effectiveness of the remaining condition remains unaffected.

The Treatment/operation risks were comprehensively explained by the treating veterinary surgeon. The undersigned has understood the above terms and conditions and accepted them as integral part of the contract. By signing the undersigned confirms that he/she concludes this contract in the name and on account of the owner.
